### Registration

- Upon successful registration, a confirmation email will be sent to the attendee. If you do not receive a confirmation, please contact LANPAC to ensure your registration has been processed. LANPAC reserve the right to refuse/cancel your registration without giving a reason.

# **Event participation**

- All attendees are expected to behave in a professional and respectful manner.
  LANPAC reserves the right to remove any attendee who does not comply with this standard.
- The content provided during events is for informational purposes only. Attendees are not permitted to record, reproduce, or distribute any event content without prior consent from LANPAC.

# Venue and specific requirements

- You must comply with the rules and regulations governing the venue. If you bring any property to the venue, you do so at your own risk. We are not responsible for any loss and/or damage to such property. If you are using car parking facilities at the venue, you do so entirely at your own risk. We do not accept any responsibility for any loss and/or damage resulting from your use of such car parking facilities. We reserve the right to refuse admission to any person whom we consider in our absolute discretion to be unsuitable for admission to the event or to remove such person after the start of the event.
